What is the overall <u>deductible</u> ?	PPO and Non-PPO <u>providers</u> combined: \$1,000/individual or \$2,000/family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your <u>deductible?</u>	Yes. PPO <u>preventive care</u> , PPO office visits, hearing services, PPO <u>urgent care</u> , PPO and Non-PPO <u>habilitation services</u> and In-Network outpatient <u>prescription drugs</u> are covered before you meet your <u>deductible</u> .
